Dear Ms Bernaerts, Dear Mr. Nuij,

I am writing to you on behalf of the industry associations APPLiA, EHI, EHPA, EPEE, Eurovent and JBCE. Our industry supports the measures governments are taking to guarantee the immediate safety and wellbeing of our communities and contain the spread of the COVID-19 virus.

During this unprecedented crisis, COVID-19 is impacting our production sites, R&D teams and support teams, slowing down internal processes and consequently our ability to provide input to the on-going process related to several Ecodesign Lots (such as for example Lot 1&2, Lot 38, Lot 39 etc).

In addition, our experts feel strongly that complex Stakeholder meetings (such as the Working Group meetings in the context of the Lot 1&2 revision) should be held in person, because they are not suited for remote participation and because they are becoming more difficult to attend even in remote, due to saturation of networks and software.

Furthermore, we strongly believe that the complexity of the discussions requires physical presence as online meetings do not provide a setting for effective debates. Since the results of the meetings affect heavily our industry, it is highly important to be able to address each other in person. We understand that it is difficult to predict the possible future dates, but the meetings could be postponed to a later date and then reassessed closer to the set timing.

In light of the situation, we would like to ask the European Commission to allow for some flexibility and extensions for different current processes as some companies and associations













have reduced their work or stopped working all together. We firmly believe everyone should have the opportunity to contribute while in this current crisis the quality of the virtual meetings and the involuntary lack of participation does not allow to reach this goal. Likewise, we would kindly ask you to consider the postponement of the Ecodesign 2020-2024 Working Plan and the revision of the Methodology for Ecodesign of Energy-related Products (MEErP) in order to ensure the participation of the stakeholders in these greatly impactful processes.

We thank you in advance for your understanding and remain at your disposal for any questions.
